

A RESOLUTION

To further extend the Governor's Declaration of a State of Emergency made on March 17th, 2020 as amended and extended.

1 **WHEREAS**, the Governor made a Declaration of a State of Emergency on March 17th,
2 2020 (the Declaration of a State of Emergency) ;and

3 **WHEREAS**, members of the Twelfth Kosrae State Legislature on April 13, 2020
4 considered whether to extend the Declaration of a State of Emergency which had by then been
5 amended, pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and then
6 resolved to extend the Declaration of a State of Emergency as amended for a period of another
7 thirty (30) days from April 17, 2020

8 **WHEREAS**, members of the Twelfth Kosrae State Legislature pursuant to Section 13
9 of Article V of the Constitution of the State of Kosrae considered the Declaration of State of
10 Emergency as amended and extended ; and

11 **WHEREAS**, members of the Twelfth Kosrae State Legislature after noticing that the
12 Declaration of State of Emergency as amended and extended is due to expire by 16 May, 2020
13 and perceiving that COVID-19 still remains a threat in regards to which precautionary measures
14 need to be further established, maintained and supplemented and thereby perceiving that it is
15 essential that the Declaration of State of Emergency as amended and extended which will expire
16 on 16 May, 2020 thereafter be extended by another 30 days to enable the Kosrae State to


continue to be in a state of preparedness to adequately respond to the threat posed by COVID-19
; NOW AND THEREFORE

BE IT RESOLVED, by members of the Twelfth Kosrae State Legislature that pursuant
to Article V, Section 13 of the Kosrae State Constitution that the Declaration of State of
Emergency as amended and extended be extended for a period of another thirty (30) days from
17 May, 2020."
