To further extend the Governor's Declaration of a State of Emergency made on March 17<sup>th</sup>, 2020 as amended and extended.

**WHEREAS**, the Governor made a Declaration of a State of Emergency on March 17<sup>th</sup>, 2020 (the Declaration of a State of Emergency); and

**WHEREAS**, Members of the Twelfth Kosrae State Legislature on April 13, 2020 considered whether to extend the Declaration of a State of Emergency which had by then been amended, pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and then resolved to extend the Declaration of a State of Emergency as amended for a period of another thirty (30) days from April 17, 2020

**WHEREAS**, members of the Twelfth Kosrae State Legislature on May 13, 2020 considered whether to extend the Declaration of a State of Emergency as amended, pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and then resolved to extend the Declaration of a State of Emergency as amended for a period of another thirty (30) days from May 17, 2020; and

**WHEREAS**, members of the Twelfth Kosrae State Legislature on June 15, 2020 considered whether to extend the Declaration of a State of Emergency as amended, pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and then resolved to extend the Declaration of a State of Emergency as amended for a period of another thirty (30) days from June 17, 2020; and

1       **WHEREAS**, members of the Twelfth Kosrae State Legislature, pursuant to Section 13 of  
2 Article V of the Constitution of the State of Kosrae, considered the Declaration of a State of  
3 Emergency as amended and extended; and

4       **WHEREAS**, members of the Twelfth Kosrae State Legislature after noticing that the  
5 Declaration of a State of Emergency as amended and extended is due to expire by 17<sup>th</sup> July, 2020  
6 and perceiving that COVID-19 still remains a threat in regards to which precautionary measures  
7 need to be further established, maintained and supplemented and thereby perceiving that it is  
8 essential that the Declaration of a State of Emergency as amended and extended which will  
9 expire on 17<sup>th</sup> July, 2020 thereafter be extended by 90 days to enable the Kosrae State to  
10 continue to be in a state of preparedness to adequately respond to the threat posed by COVID-19;

11 **NOW AND THEREFORE**

12       **BE IT RESOLVED**, by members of the Twelfth Kosrae State Legislature that pursuant  
13 to Article V, Section 13 of the Kosrae State Constitution that the Declaration of State of  
14 Emergency as amended and extended be further extended for a period of ninety (90) days from  
15 18 July, 2020 and expiring on October 15, 2020.

16       **BE IT FURTHER RESOLVED**, that a certified copy of this resolution be transmitted to  
17 the Honorable Carson K. Sigrah, Governor of the State of Kosrae.
